We, the undersigned organizations of civil society and human rights defenders from throughout the Americas, hereby express our deep concern regarding your recent announcement (Saturday, Feb. 27, 2021) before the National Assembly regarding the initiative to build a double-sided fence along the border between the Dominican Republic and Haiti, with the intention of deterring irregular migration from Haiti.

Although recurrent political crises in Haiti have exacerbated economic, social and humanitarian conditions there, with significant impact on issues related to human mobility in the Dominican Republic, the eventual responses to these by the Dominican state must respect the fundamental rights of all human beings, and in particular those of Haitian migrants and their descendants.

We consider that measures narrowly grounded in paradigms of “national security” and lacking a human rights perspective, such as the building of border walls, generate or deepen problems related to migration, instead of providing authentic, respectful, just and dignified responses. These problems include the following, among others:

- Intensification of conditions of transnational corruption and organized crime at the border
- Increase in the illegal smuggling and trafficking of migrants due to more difficult conditions related to crossing the border
- Exacerbation of discrimination against Dominicans of Haitian descent or origin, as well as migrants
- Increased levels of poverty among affected families, whose sources of income and indeed of survival depend on activities carried out on the other side of the border
- Legitimization and normalization of discourses of hate and violence by nationalist and even extremist groups
- Dissemination and promotion of greater disinformation of a xenophobic character, both in mass media and through social networks

Now, more than ever, there is a need among countries and peoples of our region for a deeper sense of Latin American and Caribbean integration, based on convergent and reciprocal responsibilities, cooperation, sisterhood and brotherhood and solidarity between us. From this perspective, the construction of a border fence or wall is unacceptable in our region.

To the contrary, our states must take measures that respect and protect the fundamental rights of all persons without discrimination motivated by race, sex, language, religion, political or other opinions, national or social origin, economic status, place of birth or any other social condition. Furthermore, this constitutes an imperative principle of the contemporary international order reflected in international standards of protection that has deep roots in our shared history as free and independent peoples throughout the American continent.

This is especially urgent, given the critical nature of the times in which we live, which remind us constantly of our underlying human condition, and underline the centrality of the values of universal solidarity and social protection, and the need to find common solutions to our shared dilemmas.

In light of all the above, Mr. President, we respectfully call upon you to rethink this initiative of interposing a wall between the Dominican Republic and Haiti, and instead to deploy the vast resources that such a project would involve towards the implementation of alternative measures consistent with human rights that could stimulate opportunities for integration and development for the benefit of both Dominicans and Haitians in the border region, as well as more regular, humane, and safe processes of migration.
